FUTURE MEETING


The next Special BOE meeting is set for Monday, July 25, 2011 at 7:00 p.m. in the Riley County High School Library.

IBB notes

July 20, 2011

Members Present: Randy Glenn, Mike Pachta, Steve Reed, Bob Whearty, Dave Taphorn, Jenneen LeMay, Brad Starnes.

Visitors Present: Dan Strom, Dan Thomson, Shane Allen, Jacqueline Loewen, Barbie Shoemaker

- I. The Board stated that all board members discussed negotiations at length on Monday, July 18th. They presented three proposals that would be of equal cost to the board—teachers are being asked to select which one they prefer.
 - a. Clarification of terminology in the proposals was discussed.
 - b. Teachers caucused. Decided it would be best for the majority to include only Proposal #1 and #2, instead of all three. Teachers will present proposals to staff and get back to the board by end of July, if not sooner.
 - i. Proposal #1:
 1. \$300 Bonus
 2. BOE pays 80% of insurance
 3. 4 days off contract (186 total)
 - ii. Proposal #2:
 1. \$500 Bonus
 2. District pays 75% of insurance
 3. 4 days off contract (186 total)
 - iii. Proposal #3:
 1. \$500 Bonus
 2. District does not pay any towards insurance (increases)
 3. 5 days off contract (185 total)
