ADMINISTRATIVE A. REPUBLISH 2011-12 BUDGET: The Kansas Department of Education auditor has finished the audit for our district. The results are that we gained 14.6 Full Time Enrollment for a total of \$55,188.00. Superintendent Starnes stated to gain authority to spend this money gain the district needs to republish the 2011-2012 budgets. All this additional money will come from state aid.
